Propylene glycol 80.00 % v/v
Cobalt sulphate heptahydrate 0.10 % v/v

For the treatment of bovine ketosis, and as an aid in pregnancy toxemia in sheep.

Cattle and sheep.

10. DOSAGE FOR EACH SPECIES, ROUTE(S) AND METHOD OF ADMINISTRATION

To be administered orally as a drench.

Cattle: 150-200 ml twice daily for 3-4 days.

Sheep: 2 ml/kg body weight up to 120 ml max.

11. ADVICE ON CORRECT ADMINISTRATION

Dose may be repeated 7-8 hours later if necessary.

If signs of disease persist or appear, consult a veterinary surgeon.

12. WITHDRAWAL PERIODS

Meat: Zero days; Milk: Zero hours.

13. SPECIAL STORAGE PRECAUTIONS

Do not store above 25°C.

Protect from light.

Protect from frost.
