Contains 6% w/v Cyromazine

Sheep and Lambs

**6. INDICATION(S)**

Contains Pink Marker Dye to aid in the identification of treated animals Pink mark will fade from the fleece in about 7 days.

Vetrazin Pour-on gives 10 weeks protection against blowfly strike on sheep and lambs. It should be applied before an anticipated blowfly challenge. Retreatment may be necessary every 8 -10 weeks under conditions of extreme blowfly challenge.

**7. METHOD AND ROUTE(S) OF ADMINISTRATION**

**DIRECTION FOR USE**

Vetrazin Pour-on must be applied with the Elanco POUR-ON GUN. Best results will be achieved by holding the gun approximately 18" from the sheep during application.

**FOR WHOLE BODY PROTECTION.**

Apply along the spine of the animal in a band at least 4" wide from the middle of the shoulders to the rump and then around the crutch and tail. Half the dose should be applied along the spine with the remainder around the crutch and tail area. Always apply full dose as instructed.

**Example:**

If animals to be treated are in the 21 - 30 kg liveweight range they should receive 30 ml of **Vetrazin** Pour-on. The most convenient way of applying this is to set the applicator to deliver 15 ml. One squirt should then be applied along the spine from the middle of the shoulders to the rump and a second squirt applied around the crutch and tail area (see diagram).

**CONTRAINDICATIONS & WARNINGS**

- Animals must not be slaughtered for human consumption during treatment.
- Sheep may be slaughtered for human consumption only after 28 days from last treatment.
- Not to be used on sheep producing milk for human consumption.
- Wear synthetic rubber gloves when transferring the product from one container to another.
- Wash splashes from skin and eyes immediately.
- Wash hands and exposed skin before meals and after work.
- Do not eat, drink, or smoke whilst using the product.
- Store in tightly closed original container.
- Store away from food, drink and animal feeding stuffs.

Dangerous to aquatic life. Do not contaminate ponds, waterways or ditches with the product or empty container.

As a precautionary measure, sheep must be kept away from watercourses for at least one hour following treatment.

Shake container before use.  
For external use only.  
Protect from frost.
