#### 1. NAME OF THE VETERINARY MEDICINAL PRODUCT

Amoxycare<sup>™</sup> 250mg, hard capsules

#### 2. STATEMENT OF ACTIVE AND OTHER SUBSTANCES

Amoxicillin as Amoxicillin Trihydrate

#### 3. PHARMACEUTICAL FORM

Red and white capsules for oral administration.

#### 4. PACKAGE SIZE

100 Capsules 500 Capsules 1000 Capsules

#### 5. TARGET SPECIES

Dogs

#### 6. INDICATION(S)

Indicated in the treatment and control of diseases caused by or associated with bacterial pathogens sensitive to Amoxicillin. These include the following groups of pathogens: *Pasteurella* spp., *Staphylococci* (penicillin sensitive strains), *Streptococci*.

When susceptible organisms are present treatment may be effective in the following indications: localised infections, alimentary tract infections, respiratory infections, urogenital tract infections, secondary bacterial infections, general infections.

### 7. METHOD AND ROUTE(S) OF ADMINISTRATION

**DOSAGE AND ADMINISTRATION:** 10 - 20 mg/kg bodyweight twice daily for seven days.

To be given by the oral route only.

The dog may be dosed with the capsule or alternatively the capsule may be added to a little feed.

#### 9. SPECIAL WARNING(S), IF NECESSARY

#### SPECIAL PRECAUTIONS FOR USE:

**Operator warning:** Penicillins and cephalosporins may cause hypersensitivity (allergy) following injection, inhalation, ingestion or skin contact.

Hypersensitivity to penicillins may lead to cross reactions to cephalosporins and vice versa.

Allergic reactions to these substances may occasionally be serious.

- 1. Do not handle this product if you know that you are sensitised or if you have been advised not to work with such preparations.
- 2. Handle this product with great care to avoid exposure, taking all recommended precautions.
- 3. If you develop symptoms following exposure such as a skin rash, you should seek medical advice and show the doctor this warning. Swelling of the face, lips or eyes, or difficulty with breathing are more serious symptoms and require urgent medical attention.
- 4. Wash hands after use.

#### **DRUG INTERACTIONS:**

Amoxicillin is unlikely to interact significantly with any of the other drugs commonly administered to dogs. It is not recommended to administer bactericidal and bacteriostatic antibiotics concomitantly.

#### **USE DURING PREGNANCY OR LACTATION:**

As with all other antibiotics, the product should be used with caution during pregnancy and lactation. There is no evidence that the use of amoxicillin presents any particular hazard either to the dam or to the foetus.

#### **CONTRA-INDICATIONS, WARNINGS etc.:**

As with all penicillins the product may cause hypersensitivity (allergy) following ingestion.

Not to be administered to animals known to be sensitive to penicillin.

Not to be administered to small herbivores.

Do not treat dogs less than 10kg bodyweight.

As with all other penicillins, bacterial resistance to amoxicillin may occur. Thus antibiotic sensitivity testing should be considered if a clinical condition fails to respond to treatment within 5 days.

In common with many antibiotics, administration of amoxicillin may disturb the gut flora.
