## **6. ADVERSE REACTIONS**

For the first hour after administration, the pet may scratch more than normal. This effect is caused by the fleas reacting to the product. In very rare cases this may present as transient signs of hyperactivity, panting, vocalization and excessive grooming/ licking.

Transient neurological signs such as muscle tremors, ataxia, and convulsions have also been reported in very rare occasions.

The frequency of adverse reactions is defined using the following convention:

- Very common (more than 1 in 10 animals displaying adverse reaction(s) during the course of one treatment)
- Common (more than 1 but less than 10 animals in 100 animals)
- Uncommon (more than 1 but less than 10 animals in 1,000 animals)
- Rare (more than 1 but less than 10 animals in 10,000 animals)
- Very rare (less than 1 animal in 10,000 animals, including isolated reports).

If you notice any serious effects or other effects not mentioned in this leaflet, please inform your veterinary surgeon.

### **BOB MARTIN CLEAR FLEA 11.4 MG TABLETS FOR CATS, SMALL DOGS AND PUPPIES**

1 – 11kg            1 tablet (11.4mg Nitenpyram)

### **BOB MARTIN CLEAR FLEA 57 MG TABLETS FOR LARGE DOGS**

11.1 – 57kg       1 tablet (57mg Nitenpyram)

Over 57kg        2 tablets (57mg Nitenpyram)

Bob Martin Clear Flea Tablets can be given directly into the mouth or disguised in a little food.

## **9. ADVICE ON CORRECT ADMINISTRATION**

### **HOW DO I USE THIS PRODUCT SAFELY?**

Read the package leaflet before use.

### **WHEN SHOULD YOU USE BOB MARTIN CLEAR FLEA TABLETS?**

Give the tablets any day when fleas are detected. Repeat on any subsequent day but do not give more than one treatment per day.

Fleas can be detected by parting the pet's coat to examine the skin or by combing its coat with a fine toothed flea comb. Frequent scratching or excessive grooming can also be signs of flea infestation.

Kills fleas fast

- Starts killing fleas in 15 minutes
- Kills 100% of fleas in 24 hours

Bob Martin Clear Flea Tablets are an effective method of killing adult fleas on your pet but can only be fully effective as part of a programme to eliminate fleas and larvae on the pet and in the pet's surroundings. Pet bedding and favourite resting areas should be vacuumed regularly and treated with a suitably approved insecticide preferably containing an Insect Growth Regulator (IGR). Consult your Veterinary Surgeon if signs of disease persist.
