1. NAME OF THE VETERINARY MEDICINAL PRODUCT

Radiol Insecticidal Soapless Shampoo with Conditioner.

2. STATEMENT OF ACTIVE AND OTHER SUBSTANCES

Piperonyl Butoxide (100%) 0.084%w/w added as Piperonyl Butoxide, Pyrethrum Extract 0.04%w/w (pyrethrins 0.01%w/w)

3. PHARMACEUTICAL FORM

Shampoo.

4. PACKAGE SIZE

500ml

5. TARGET SPECIES

Horses

6. INDICATION(S)

The effective insecticidal shampoo recommended for show preparation and the treatment of lice infestations in horses.

7. METHOD AND ROUTE(S) OF ADMINISTRATION

Thoroughly soak the coat with warm water containing one part Radiol Insecticidal Shampoo in ten parts of warm water, pouring the diluted Radiol Insecticidal Shampoo with conditioner over the back of the horse. Rub into a good lather with a soft brush adding more water as necessary. When clean, rinse the horse thoroughly and dry. Take care to prevent the shampoo from entering the eyes or the mucous membranes.

In cases of lice infestation use at least 1litre of shampoo per horse and ensure that all parts of the body are shampooed. Leave in contact for at least 10 minutes before rinsing off. Repeat 10-14 days later.

8. WITHDRAWAL PERIOD

Not to be used on horses intended for human consumption. Treated horses may never be slaughtered for human consumption. The horse must have been declared as not intended for human consumption under the national passport legislation.

9. SPECIAL WARNING(S), IF NECESSARY

Protective clothing, including rubber gloves and apron, should be worn while using the product. Avoid contact with eyes. In case of accidental eye contact, rinse with clean, fresh water. If eye irritation persists, seek medical advice. Persons who are hypersensitive (allergic) to pyrethrum extract should handle with care. Treated animals should not be handled until the animal is dry. Do not eat, drink or smoke while using the product.

Do not use on horses with known hypersensitivity to the active ingredients. If signs of disease persist or appear consult your veterinary surgeon.

11. SPECIAL STORAGE CONDITIONS

Store in tightly closed original container. Keep away from food, drink or animal foodstuffs. Do not store above 25°C. Protect from frost and direct sunlight.

12. SPECIFIC PRECAUTIONS FOR THE DISPOSAL OF UNUSED PRODUCTS OR WASTE MATERIALS, IF ANY

Harmful to fish and aquatic life. Do not contaminate ponds, waterways or ditches with the product or containers. Dispose of unused product, part used and empty containers in the domestic refuse.


