## 2. STATEMENT OF ACTIVE AND OTHER SUBSTANCES

Piperonyl Butoxide (100%) 0.084%w/w added as Piperonyl Butoxide, Pyrethrum Extract 0.04%w/w (Pyrethrins 0.01%w/w)

## 3. PHARMACEUTICAL FORM

Shampoo.

### 4. PACKAGE SIZE

500ml, 1L, 5L, 25L

### 5. TARGET SPECIES

Horses

## 6. INDICATION(S)

For the treatment of lice infestation, routine coat care and show preparation.

## 7. METHOD AND ROUTE(S) OF ADMINISTRATION

Thoroughly saturate the coat with one part Dermoline Shampoo in ten parts of warm water, pouring this as required over the back of the horse. Rub this into a good lather with a soft brush adding more water as necessary. When clean, rinse thoroughly and dry. Take care to prevent the shampoo from entering the eyes or coming into contact with mucous membranes.

**In cases of lice infestation** use at least 1litre shampoo per horse and ensure that all parts of the body are shampooed. Leave in contact for at least 10 minutes before rinsing off. Repeat 10-14 days later. To help prevent re-infestation, the horse's stable, blankets and grooming equipment etc. should also be treated with a suitable insecticide.

## 8. WITHDRAWAL PERIOD

Not to be used on horses intended for human consumption. Treated horses may never be slaughtered for human consumption. The horse must have been declared as not intended for human consumption under the national passport legislation.

## 9. SPECIAL WARNING(S), IF NECESSARY

## **Operator warnings:**

Protective clothing, including rubber gloves and apron, should be worn while using the product. Avoid contact with eyes. In case of accidental eye contact, rinse with clean, fresh water. If eye irritation persists, seek medical advice. Persons who are hypersensitive (allergic) to pyrethrum extract should handle the product with care. Treated animals should not be handled until the animal is dry. Do not eat, drink or smoke while using the product. Wash hands and exposed skin after use.

### Contra – indications:

Do not use on horses with known hypersensitivity to the active ingredients. If signs of disease persist or appear consult your veterinary surgeon.
