1. NAME OF THE VETERINARY MEDICINAL PRODUCT

Dermoline Sweet Itch Lotion. - Pour-on solution.

2. STATEMENT OF ACTIVE AND OTHER SUBSTANCES

Piperonyl Butoxide (100%) 0.5% v/v added as Piperonyl Butoxide, Pyrethrum Extract 0.4% v/v.

3. PHARMACEUTICAL FORM

Pour-on solution. Clear oily liquid

4. PACKAGE SIZE

500ml

5. TARGET SPECIES

Horses

6. INDICATION(S)

An oily lotion for application to the mane and tail of horses as an aid in the prevention of sweet itch.

7. METHOD AND ROUTE(S) OF ADMINISTRATION

Apply the lotion in advance of the start of the season when the midge Culicoides become active (April). It is recommended that a small skin test under the mane should be carried out 24 hours before proper use.

First application: Apply liberally to the mane and tail with a soft brush, parting the hair on the mane and tail to apply the lotion to the skin.

Subsequent applications: Top up once or twice daily with a smaller amount of lotion throughout the spring, summer and early autumn. After shampooing the mane and tail, a heavy application should be made again.

Horses that are prone to sweet itch should be stabled if possible at dawn and dusk. If signs of disease persist or appear consult your veterinary surgeon.

8. WITHDRAWAL PERIOD

Not to be used on horses intended for human consumption. Treated horses may never be slaughtered for human consumption the horse must have been declared as not intended for human consumption under national horse passport legislation.

9. SPECIAL WARNING(S), IF NECESSARY

Wear rubber gloves when applying the product. Avoid contact with eyes. In case of accidental eye contact, rinse with clean fresh water. If eye irritation persists, seek medical advice. Persons who are hypersensitive (allergic) to pyrethrum should handle the product with care. Treated animals should not be handled until dry. Do not eat, drink or smoke while applying the product. Wash hands and exposed skin after use.

Store in tightly closed original containers. Do not store above 25°C.
