Worn as directed the collar will kill fleas and prevent further infestation for up to 4 months. The collar contains a modern insecticide that when used as recommended has a wide margin of safety.

7. METHOD AND ROUTE(S) OF ADMINISTRATION

Directions for use

Fasten the collar ensuring a comfortable fit. If fitted on a growing dog remember to loosen the collar as the dog gets bigger. For fully grown dogs correct fitting will allow two fingers to be inserted between the collar and neck. Cut off excess collar extending beyond the buckle and dispose of safely.

After fitting the collar, do not allow dog to swim in ponds or other small bodies of water. This will not adversely affect the activity of the collar, but is potentially dangerous to aquatic life.

Flea kill begins almost immediately and re-infestation is prevented for the 4 months that the collar is worn. It is unaffected by water and need not be removed even when the dog is bathed. The collar does not give off harmful vapours, leak, or stain the coat.

To help prevent re-infestation, dogs bedding and regular resting areas including carpets and soft furnishings should be treated with a suitable insecticide and vacuumed regularly.

Remove fleas from young puppies and nursing females by careful use of a flea comb.

If signs of disease persist or appear, consult your veterinary surgeon.

Contra-indications

1. No other insecticides should be used with the collar or within 7 days of removal.
2. Do not use if your dog is unwell or recovering from an illness.
3. Remove the collar if any sign of skin irritation should occur.
4. Check the collar is not too tight to ensure against irritation.
5. Do not use on nursing females.
6. Do not use this collar on dogs younger than 3 months.
7. Do not allow animals to chew collar.

Operator warnings

1. Wash hands thoroughly after handling the collar.
2. Dimpylate is an organophosphorus compound. Do not handle the collar if under medical advice not to work with anticholinesterases.
3. Do not allow children to play with the collar.
4. Do not allow children to suck or chew the collar.
5. Do not sleep with pets wearing collars.
6. Do not smoke, eat or drink while handling collar.
7. If you feel unwell following the use of this product, seek medical advice.
