7. METHOD AND ROUTE(S) OF ADMINISTRATION

How do I use it? Weigh your pet carefully and calculate the number of tablets needed. Give the tablet(s) in the morning, when your dog's stomach is empty, with about a fifth of your dog's daily food. Do not feed again until eight hours later. The tablets are film coated and must be fed whole, not broken or divided. Treat dogs separately and make sure only the dog to be treated has access to the food. Puppies (up to 24 weeks) treat at 12, 16 and 24 weeks as a precaution against Roundworm. An alternative worming product must be used in younger puppies. Nursing bitches should be treated at the same time and as frequently as puppies up to 12 weeks of age. Adult Dogs (over 24 weeks) treat every 3-6 months. Fleas transmit the most common Tapeworm, so to reduce Tapeworm infection effective flea control is required.

Dosing Instructions

Give one tablet for each 2kg (4lb 6oz) of bodyweight.

2.1kg (4lb 10oz) – 4kg (8lb 13oz) two tablets.

4.1kg (9lb) – 6kg (13lb 3oz) three tablets.

For dogs weighing more than 8kg (17.5lb), use Pets with Wilko One Dose Worming Tablets For Dogs, 500mg film-coated tablets.

If symptoms of disease persist or appear consult your Veterinary Surgeon.

2. NAME OF THE VETERINARY MEDICINAL PRODUCT

Pets with Wilko One Dose Worming Tablets for Small Dogs and Puppies, 100 mg Film-coated Tablets

3. STATEMENT OF THE ACTIVE SUBSTANCE (S) AND OTHER INGREDIENTS

Each tablet contains Nitroscanate 100mg.

4. INDICATION(S)

For the treatment the following nematodes (roundworms) and cestodes (tapeworms): Nematodes: *Toxocara canis*, *Toxascaris leonina*, *Uncinaria stenocephala*, *Ancylostoma caninum*. Cestodes: *Taenia hydatigena*, *Taenia pisiformis*, and *Dipylidium caninum*.

5. CONTRAINDICATIONS

Do not use in dogs weighing less than 2 kg.

Do not repeat treatment if vomiting occurs shortly after dosing.

Do not administer if your pet is sick or recovering from an illness.

Do not use in known cases of hypersensitivity to the active substance or to any of the excipients. If a hypersensitivity reaction occurs treatment should be discontinued.

6. ADVERSE REACTIONS

During the post-marketing surveillance, transient gastrointestinal signs (vomiting and diarrhoea); systemic sign (lethargy) and neurological sign (ataxia) have been observed very rarely.

The frequency of adverse reactions is defined using the following convention:

- very common (more than 1 in 10 animals treated displaying adverse reaction(s))
- common (more than 1 but less than 10 animals in 100 animals treated)
- uncommon (more than 1 but less than 10 animals in 1,000 animals treated)
- rare (more than 1 but less than 10 animals in 10,000 animals treated)
- very rare (less than 1 animal in 10,000 animals treated, including isolated reports).

8. DOSAGE FOR EACH SPECIES, ROUTE(S) AND METHOD OF ADMINISTRATION

Dosing Instructions

Dose: For treatment of roundworm and tapeworm in small dogs and puppies give 1 x 100mg tablet per 2kg (4.4lb) bodyweight, equivalent to 50mg nitroscanate/kg bodyweight.

Follow the dosage chart below:

Dog's weight	Example breed	Number of tablets
2.1kg (4lb 10oz) – 4kg (8lb 13oz)	Miniature Dachshund	Two
4.1kg (9lb) – 6kg (13lb 3oz)	Miniature Poodle	Three

For dogs weighing more than 8kg (17.5lb) use Pets with Wilko One Dose Worming Tablets for Dogs, 500mg film-coated tablets.

How Do I Use It?

The product should be administered orally in the morning after overnight fasting with approximately one-fifth of the daily food ration. The tablet(s) should be given whole. Tablets are film-coated and should not be broken or divided.

To reduce the risk of vomiting, it is recommended that the remaining food ration is withheld for at least 8 hours afterwards.

9. ADVICE ON CORRECT ADMINISTRATION

Pets with Wilko One Dose Worming Tablets for Small Dogs & Puppies, 100mg will kill Tapeworms, Roundworms and Hookworms. Pets with Wilko One Dose Worming Tablets for Small Dogs & Puppies, 100mg can safely be used on puppies from 12 weeks of age. Puppies should be dosed at 12, 16 and 24 weeks. Adult dogs should be dosed every 3 to 6 months as a preventative measure. If signs of disease persist or appear, consult your Veterinary Surgeon. There is no permanent treatment for these worms, therefore routine worming is essential, especially if the animal is suffering from a flea infestation. Worms are very common parasites that can cause irritation and suffering and could hinder development or lead to serious illness. Symptoms vary, but can include traces of blood or worms in the faeces, ravenous appetite without a corresponding increase in weight, attempts at vomiting and a marked deterioration in coat condition and breath.

Further Information:

1. It is recommended that adult dogs should be wormed routinely 2 – 4 times a year. Since the most common tapeworm of the dog (*Dipylidium Caninum*) is transmitted by a flea and has a very short pre-patent period, it is important to pay attention to flea control to reduce the incidence of tapeworm in your pet.
2. It is important to worm young puppies very regularly for roundworm with a suitable product. Pets with Wilko One Dose Worming Tablets for Small Dogs & Puppies, 100mg can be used at 12, 16 and 24 weeks of age. Nursing bitches should be treated at the same time and as frequently as puppies up to 12 weeks of age. Thereafter the adult worming regime of 2 – 4 times a year is recommended.


