10. DOSAGE FOR EACH SPECIES, ROUTE(S) AND METHOD OF ADMINISTRATION

Wash and dry udders and teats before milking.

Teat dipping:

Directly after milking each cow, dip the entire length of each teat in Deosan Super Excel. No dilution is required. The teat cup should be filled to about full. Replenish the teat dip cup as necessary. Teat dip cups should be emptied after milking and washed before re-use.

Teat spraying:

Immediately after milking each cow, spray the entire surface of each teat of every cow with Deosan Super Excel. No dilution is required.

If signs of disease persist or appear, consult your veterinary surgeon
