6. INDICATION(S)

Dilutable iodophor teat dip/spray for use as an aid in the control of bovine mastitis.

9. TARGET SPECIES

Dairy cows

10. DOSAGE FOR EACH SPECIES, ROUTE(S) AND METHOD OF ADMINISTRATION

Wash and dry udders and teats before milking.

Teat disinfection – This is a concentrated formulation. Dilute with water before use. Discard any remaining unused diluted solution.

Dipping:

Mix 1 part Super Iodip to 3 parts water. Directly after milking each cow, dip the entire length of each teat in the product. Replenish dip cup as necessary. Teat dips should be emptied after milking and washed before re-use. Prepare a fresh solution daily.

Spraying:

Dilution is required. Add 1 part of product to 4 parts water. Immediately after milking each cow, spray the entire surface of each teat of every cow with the product.

If signs of disease persist or appear consult your veterinary surgeon.

11. ADVICE ON CORRECT ADMINISTRATION

Do not mix with other chemicals

12. WITHDRAWAL PERIOD

Meat/Milk: Zero days/hours

13. SPECIAL STORAGE PRECAUTIONS

Do not store above 25°C.

Protect from direct sunlight. Protect from frost.

Store in tightly closed original container.

For external use only

When using as a spray, avoid working in spray mist. Avoid contact with eyes. In case of contact with eyes, rinse immediately with plenty of water and seek medical advice. In case of ingestion seek medical attention immediately. Wash hands and exposed skin after use. Do not eat, drink or smoke while using the product. Keep away from food, drink and animal feedstuffs.
