Wash and dry udders and teats before milking

Directly after milking each cow, dip the entire length of each teat in Thixodiop BA. No dilution is required. The teat cup should be kept topped up as necessary.

Teat dip cups should be emptied after milking and washed before re-use.

If signs of disease persist or appear consult a veterinary surgeon.

#### **11. ADVICE ON CORRECT ADMINISTRATION**

This product is used without dilution. Do not mix with other chemicals.

Meat/milk – zero days/hours.
