10. DOSAGE FOR EACH SPECIES, ROUTE(S) AND METHOD OF ADMINISTRATION

Immediately after milking use a clean dip cup with Blu-gard at full strength. Submerge entire teat in Blu-gard. Allow to air dry – do not wipe.

Just prior to next milking, wash and dry entire udder and teats thoroughly.

11. ADVICE ON CORRECT ADMINISTRATION

If product in dip cup becomes dirty, discard. Always use fresh full strength Blu-gard.

Do not mix Blu-gard with any other teat dip or other products.
