What does this powder do?

Wilko dog flea powder controls fleas on your dog and prevents their return for 3-4 days. AS fleas can also live in your carpets and in your dog's bedding you should treat these areas with a suitable insecticide and vacuum regularly.

Is this powder safe for my dog?

Yes, however you should not us it if your dog is less than 12 weeks old, or is feeding puppies. In all of these cases, use a flea comb or speak to a vet. Do not use on nursing females.

10. DOSAGE FOR EACH SPECIES, ROUTE(S) AND METHOD OF ADMINISTRATION

Only use when your dog's coat is dry. Stand the animal on a sheet of paper or outdoors and comb or brush the coat the wrong way, to expose the skin underneath, then apply the amount indicated below directly onto the skin. Brush excess powder off your dog's coat straight away and brush all the powder out after 30 minutes. For a small dog such as a terrier use 5-10 g of powder, the pack contains sufficient for 8-16 applications. For a medium sized dog such as a Collie use a total of 10-15 g of powder, the pack contains sufficient for 5-6 applications. For a large dog such as a German Shepherd use a total of 15-20 g of powder, the pack contains sufficient for 4-5 applications.

Store in a dry place.

Do not store above 25°C.

Avoid getting into your dog's eyes, mouth or ears or other sensitive areas. This powder is for external use only. If signs of disease persist or appear consult your veterinary surgeon. In case of adverse reaction, consult your veterinary surgeon.

Avoid inhaling the powder. Use in a well ventilated area.

Wash hands and exposed skin after use.

Avoid contact with eyes. In case of accidental eye contact, rinse with clean, fresh water. If eye irritation persists, seek medical advice.

Persons who are hypersensitive (allergic) to pyrethrum extract should handle the product with care.

Treated animals should not be allowed to sleep or play with people, particularly children, until the powder has been brushed out.
