INDICATIONS

CONTRAINDICATIONS

None known.

ADVERSE REACTIONS

Depression and reduction of appetite may occur after administration. These symptoms generally disappear within a few days.

Swelling of about two centimetres in diameter, which may be of hard consistency, may be observed at the site of injection in about 2.4 % of the cases. These swellings will disappear within one to two days.

TARGET SPECIES

Fattening pigs.
