Each 400ml contains:

11.88g Calcium provided by Calcium Gluconate and Calcium Borogluconate. Also contains 6.5% w/v Boric Acid.

Indicated in the treatment of hypocalcaemia in cattle.

7. METHOD AND ROUTE(S) OF ADMINISTRATION

By subcutaneous or slow intravenous injection.

Cattle: 150-500 ml.

8. WITHDRAWAL PERIOD

Meat : Zero days

Milk : Zero hours

9. SPECIAL WARNING(S), IF NECESSARY

Observe aseptic precautions.

Warm to body temperature before administration. Intravenous injections should be given slowly. Sites of subcutaneous injection should be massaged gently.

This product does not contain an antimicrobial preservative. The product is intended for single use only. Any solution remaining in the bottle after withdrawal of the required dose should be discarded.

Care should be taken to avoid accidental self-injection: may cause irritation at site of injection.
