6. INDICATION(S)

One pack is sufficient to treat one cat up to 5 kg (11 lbs) weight for roundworms (Ascarids) and tapeworms.

7. METHOD AND ROUTE(S) OF ADMINISTRATION

Directions for use: The treatment consists of three doses given at weekly intervals. Tablets may be taken whole or crushed and sprinkled on the cat's food.

FIRST DOSE: Give the appropriate number of PINK tablets (for roundworm) for the cat's weight, as shown below.

SECOND DOSE: One week later give the same number of FAWN tablets (for tapeworm).

THIRD DOSE: After another week, repeat the first dose of PINK tablets (for roundworm).

Weigh your pet before treatment to accurately establish the correct dosage (weigh yourself, with and without the cat, on the bathroom scales. The difference is the weight of the cat).

For cats weighing more than 5 kg (11 lbs) give one extra tablet per kg.

Dose routinely every 3 months.

Nursing females should be treated for roundworms (Ascarids) 2 weeks after giving birth, and every 2 weeks until weaning.

9. SPECIAL WARNING(S), IF NECESSARY

Contra indications/warnings.

Do not remove tablets from strip until required for treatment. Any part-used tablets should be discarded. Do not repeat treatment if vomiting occurs shortly after dosing. Do not treat cats under 0.6 kg (1.5 lbs) or less than 6 months old. Whilst use of this product is normally free from side-effects, some animals may show a reaction. In such cases, consult your Veterinary Surgeon. Consult your Veterinary Surgeon before treating pregnant animals, and those with a history of epilepsy or severe renal dysfunction.

If signs of disease persist or appear, consult a Veterinary Surgeon.

Wash hands after handling tablets. Accidental eye contact - rinse thoroughly with clean, running water. If irritation persists, seek medical advice. Accidental ingestion by humans - drink plenty of water and seek medical advice.
