6. INDICATION(S)

When used as a teat dip or teat spray Sensospray 70V is an aid in the prevention of mastitis in lactating dairy cattle, sheep and goats.

Lactating dairy cattle, sheep and goats.

10. DOSAGE FOR EACH SPECIES, ROUTE(S) AND METHOD OF ADMINISTRATION

Pre Milking: Wash teats with an udder wash solution and dry with a disposable paper towel before next milking.

Post Milking: If signs of disease persist or appear, consult your veterinary surgeon.

Teat Dipping: Fill dipping beakers 2/3 full and apply to the teats of lactating cows, sheep or goats. Teat dipping beakers should be emptied after milking and washed before re-use. Replenish dipping beakers after each milking.

Teat Spraying: Immediately after the milking of cows, sheep and goats spray the entire surface of each teat. If the spray nozzle is adjustable, use a coarse spray (not a fine mist).

Meat & offal: Zero days / Milk: Zero hours

13. SPECIAL STORAGE PRECAUTIONS

Do not store above 25 °C.

Protect from frost.
