1. NAME OF THE VETERINARY MEDICINAL PRODUCT

Johnson's Pigeon Insect Spray

2. STATEMENT OF ACTIVE AND OTHER SUBSTANCES

Contains permethrin for lasting protection

3. PHARMACEUTICAL FORM

Water based spray containing permethrin

4. PACKAGE SIZE

250ml

5. TARGET SPECIES

Pigeons

6. INDICATION(S)

Kills mites, lice etc.

7. METHOD AND ROUTE(S) OF ADMINISTRATION

Directions: Treat birds singly inside the loft. Spray each bird for 4 – 6 seconds nonly according to size. Spray lightly at rear of the bird from about 38cm (15”), Parting feathers. Avoid eyes. Avoid spraying over food and water containers. Repeat every 3 – 4 days until infestation is cleared. Use occasionally as a precaution, particularly after racing or showing. To help prevent re-infestation, also allow spray to fall on surroundings such as baskets, fittings, lofts. NOTE: Most effective way of treatment: one person holds bird, protecting it's eyes with one hand, while second person parts feathers and applies spray.

8. WITHDRAWAL PERIOD

9. SPECIAL WARNING(S), IF NECESSARY

Not to be used on pigeons intended for human consumption. Sick or convalescing birds should be treated by a veterinary surgeon. Do not spray on delicate underwings BUT USE A SUITABLE INSECT POWDER. Do not spray closer than

15" (38cms). Do not exceed stated dose. If symptoms persist, consult a Veterinary Surgeon promptly.

Extremely flammable. Do not pierce or burn even after use. Do not spray on a naked flame or any incandescent material. Keep away from sources of ignition – No smoking.

Operator Warnings

Do not breathe spray mist. Use in well ventilated area. Avoid contact with eyes.
Wash hands after use. Keep away from food and drink. Harmful to fish, crustaceans and reptiles – do not contaminate aquaria, fish bowls, etc. For animal treatment only.


