1. NAME OF THE VETERINARY MEDICINAL PRODUCT

Dysect® Cattle Pour-On Solution 15 g/litre

2. STATEMENT OF ACTIVE AND OTHER SUBSTANCES

Ready to use oil based insecticide containing 15 g/litre alphacypermethrin

3. PHARMACEUTICAL FORM

Pour-On Solution

4. PACKAGE SIZE

1 litre

5. TARGET SPECIES

Cattle

6. INDICATION(S)

For the treatment and control of flies and lice on cattle.

Fly Control – To control biting and nuisance flies, treatment should be repeated as necessary. Frequency of application will depend on the numbers and species of flies present; normally nuisance flies on the head and face can be controlled for up to 4/5 weeks and the biting horn fly for up to 8 weeks.

Lice Control – To control sucking and biting lice, one application treatment will normally eradicate all the lice. If a few lice survive on individual animals, it may be necessary on very rare occasions to re-treat an animal.

7. METHOD AND ROUTE(S) OF ADMINISTRATION

For external use only.

Apply a single 10 ml dose, with the applicator gun, from the crown of the head down the neck and along the middle of the back of the animal.

How to apply Dysect Cattle Pour-On

Using the applicator gun:

- 1) Remove transit cap.
- 2) Fit the spouted cap to the bottle.
- 3) Attach the delivery tube from the gun to the spouted cap.
- 4) Adjust the gun to deliver 10 ml.

Apply from the crown down the neck and along the middle of the back of the animal.

8. WITHDRAWAL PERIOD

Animals must not be slaughtered for human consumption during treatment.

Meat: 28 days.

Milk: Zero hours.

9. SPECIAL WARNING(S), IF NECESSARY

Signs of discomfort may be exhibited by some animals after treatment. This will not last longer than 48 hours and will have no long lasting effect on the animal.

Protection of operators:

Wear waterproof apron and boots and impervious gloves when applying the product and when handling recently treated animals. Wash splashes from skin and eyes immediately. Remove heavily contaminated clothing and wash before re-use. Wash hands and exposed skin before eating, drinking or smoking and after work.

Store in tightly closed original container.

Do not store above 25°C.

Store away from food, drink and animal feedstuffs.

Any unused veterinary medicinal product or waste materials derived from such veterinary medicinal products should be disposed of in accordance with local requirements.
