# 10. DOSAGE FOR EACH SPECIES, ROUTE(S) AND METHOD OF ADMINISTRATION

### **Teat dipping**

For routine dipping use a solution of one part of this product with three parts of clean water to give 5000ppm available iodine minimum. Fill a suitable teat dip cup about two-thirds full with the prepared solution and dip each teat immediately after milking. Ensure the full length of the teat is covered. Replenish the teat dip cup as necessary. Teat dip cups should be emptied after use and washed before re-use. Wash and dry udder before next milking.

## Teat spraying

For routine spraying, use a solution of one part of this product with three parts of clean water immediately after each milking. Ensure that the entire surface of each teat is covered during spraying. Wash and dry teats and udder before next milking.

# **Udder Washing and Cluster Dipping**

Prepare a fresh solution daily. Dilute this product in the proportion one part with 500 parts clean water to give 40 ppm minimum available iodine (1 fl oz in 3 gallons, 20 mls in 10 litres). To help prevent cross infection, the use of a separate udder cloth for each cow or disposable paper towels is strongly recommended. Udder cloths should be allowed to soak in the solution. Dry teats before milking. Immerse clusters and agitate for at least half a minute. Rinse thoroughly in clean water before use.
