3. STATEMENT OF THE ACTIVE SUBSTANCE(S) AND OTHER INGREDIENTS

Iodine, Glycerol and Sorbitol.

4. PHARMACEUTICAL FORM

This product contains 0.535% w/v AVAILABLE IODINE and 8.32% w/v GLYCEROL and 0.5% w/v SORBITOL. 0.5% w/v available Iodine when used undiluted as a teat dip.

Product information

An iodophor-based solution which has been specially formulated to leave antiseptic film of iodine adhering to teats after dipping.

Should be used all year round and especially at times when teat condition is compromised.

Contains 8.5% w/v Glycerol and 0.5% w/v Sorbitol to help keep teats soft and supple and to aid in the prevention and healing of sores and cracks.

5,25,60,200 and 1000L

Additional wording required on 200 and 1000 litre labels

200 litre label: This container should only be used once and should not be returned for re-filling.

1000 litre label: This container should only be used once and should not be returned for re-filling. Ensure that all equipment and containers used for decanting not more than enough product for use that day, are fit for purpose, clean, emptied after use and washed before re-use.

10. DOSAGE FOR EACH SPECIES, ROUTE(S) AND METHOD OF ADMINISTRATION

Teat dipping

Fill teat cup about two-thirds full with Visqodip 0.535% w/v ready-to-use teat dip solution. Dip teats of every cow immediately after each has been milked, making sure that the full length of the teat is immersed. Top up with fresh solution as required. Empty and wash out cups after milking. Dry teats before milking. Not suitable for spraying due to viscous nature of the formulation.

11. ADVICE ON CORRECT ADMINISTRATION

For professional use only.

Avoid contact with eyes. In case of contact with eyes, rinse with clean running water and seek medical advice. In case of ingestion seek medical advice immediately. When using do not eat, drink or smoke. Wash hands after use. Keep away animal feedstuffs.

Meat-zero days Milk-zero hours.

Store in tightly closed original container. Do not store above 25°C. Protect from frost. If contents freeze they must be thawed and thoroughly mixed before use.
