What does this product do?

Beaphar Dog Flea Spray is a spray solution which controls fleas on your dog and prevents their return for 3-4 days. Repeat after 3-4 days if any re-infestation is apparent. Most fleas live around the dogs immediate environment, including carpets, soft furnishings and dog

beds, so it's important these areas are treated with a suitable household insecticide and vacuumed regularly.

Comb your dog's fur the wrong way, to expose skin. Spray the root of the fur and skin with Beaphar Dog Flea Spray from a distance of 15cm, following the size guidelines below. Work from tail to head. Comb the coat back into place and remove any excess moisture straight away by drying with a towel. Do not exceed recommended dosage.

Is this product safe for my dog?

Beaphar Dog Flea Spray is safe for almost all dogs. However, do not use on dogs under 12 weeks old, if your dog is sick, getting over an illness or is feeding puppies. In these cases, use a flea comb or speak to your vet.

What precautions should I take to protect my dog?

Do not use the spray whilst using any other flea control products on your dog. Do not spray into your dog's eyes, mouth or ears, or onto other sensitive areas. Make sure your
