1. NAME OF THE VETERINARY MEDICINAL PRODUCT

Johnson's Veterinary Easy Round Wormer Granules for Cats & Kittens 222.2 mg

2. STATEMENT OF ACTIVE AND OTHER SUBSTANCES

Each 1g sachet contains 222.2mg of fenbendazole, as a ready to administer oral anthelmintic for cats.

6. INDICATION(S)

A broad spectrum anthelmintic for the treatment of domestic cats infected with immature and mature stages of common roundworms of the gastro-intestinal tract. It also has an ovicidal effect on nematode eggs.

7. METHOD AND ROUTE(S) OF ADMINISTRATION

For the routine treatment of adult cats, a dosage of 100mg/kg bodyweight is recommended. Very small or unweaned kittens should be treated with a suitable licensed product up to 12 weeks of age. The dose should be administered by mixing into the feed. Assess bodyweight as accurately as possible before calculating the dosage. Add to feed immediately before administration. Discard any remaining medicated feed.

This 1g sachet will treat:

- **Routine treatment of adult cats (100mg/kg): 1 sachet Johnson's 222.2mg granules per 2.2kg (5lb) bodyweight as a single dose.**
- **Weaned kittens (over 12 weeks old) under 6 months of age (50mg/kg): 1 sachet per 4.4kg (10 lb) bodyweight for 3 days.**

Practical dosage recommendations:

For the treatment of weaned kittens (over 12 weeks old and under 6 months of age) 50mg/kg: 1 sachet per 4.4kg (10 lb) bodyweight daily for 3 days is recommended.

3. STATEMENT OF THE ACTIVE SUBSTANCE (S) AND OTHER INGREDIENTS

What is in this product:

Each 1g sachet contains 222.2mg of fenbendazole which is a benzimidazole compound.

4. INDICATION(S)

What this product does:

This product kills common roundworms which can infect cats. The product also kills roundworm eggs, thereby helping to reduce the chance of human infection from faeces.

5. CONTRAINDICATIONS

None known

6. ADVERSE REACTIONS

If symptoms of disease persist or appear, consult your veterinary surgeon.

If you consider that this product has not worked or has caused your cat to become unwell, consult a veterinary surgeon and write to the distributor.

7. TARGET SPECIES

Cats

8. DOSAGE FOR EACH SPECIES, ROUTE(S) AND METHOD OF ADMINISTRATION

Administer 1g of Johnson's Veterinary Easy

Round Wormer Granules per 2.2kg (5lb) bodyweight as a single dose (= 100mg fenbendazole/kg bodyweight).

Practical dosage recommendations:

1.1 – 2.1kg	(2.5 - 5lb)	1g sachet
2.2 – 4.4kg	(5 - 10lb)	2 x 1g sachet
4.5 – 7kg	(10 – 15lb)	3 x 1g sachet

9. ADVICE ON CORRECT ADMINISTRATION

For the treatment of weaned kittens (over 12 weeks old and under 6 months old) 50mg/kg for 3 days is recommended.

Very small or unweaned kittens should be treated with a suitable licensed product up to 12 weeks of age.

Give this medicine by mixing the granules with the animal's usual food. After treatment, the pet may become naturally reinfected with worms. It is therefore advisable to treat adult cats every three months to keep such reinfection to a minimum.
