Each tablet contains Piperazine Citrate Ph Eur 500mg

Dogs and Cats

**6. INDICATION(S)**

For the control of Ascarids and Hookworm in dogs and cats.

**7. METHOD AND ROUTE(S) OF ADMINISTRATION**

Dosage Schedule

Preliminary fasting and subsequent purging are unnecessary and a single dose is usually adequate.

Dogs and Cats

20mg/kg (1 tablet per 2.5kg: ½ tablet per 1.25kg bodyweight). Repeat treatment at 3 monthly intervals. Puppies and kittens should be treated at 2 weeks of age and every 2 weeks until 12 weeks of age. Thereafter, they should be treated at 3 month intervals. Nursing bitches and queens should be treated 2 weeks after giving birth and every 2 weeks until weaning. It is advisable to treat bitches and queens at the same time as the puppies or kittens.

## **9. SPECIAL WARNING(S), IF NECESSARY**

### Contraindications

Do not repeat if vomiting occurs shortly after dosing.

Do not administer more than 6 tablets in a single dose.

If no vomiting occurs remaining dose may be given after 3 hours.

### General Precautions

Whilst piperazine compounds have few side effects and are of low toxicity, care should be taken, especially with kittens and puppies to ensure that the correct dosage is calculated by weighing the animal prior to administration of the drug (see leaflet) Animals weighting less than 1.25kg should be treated with a suitable anthelmintic licensed for this purpose.

Consult a veterinary surgeon before treating pregnant animals or those with a history of epilepsy or severe renal dysfunction.

### Further information

Transient neurological effects and urticarial reactions have been occasionally reported.

Wash hands immediately after administering the tablets.

## **8. DOSAGE FOR EACH SPECIES, ROUTE(S) AND METHOD OF ADMINISTRATION**

### Puppies and Kittens

200mg/kg as a single dose (1 tablet per 2.5kg bodyweight).

1<sup>st</sup> dose: 2 weeks of age

2<sup>nd</sup> dose: 2 weeks later

Subsequent doses: every 2 weeks of age until 3 months of age and then at 3 monthly intervals.

### Nursing Bitches and Queens

They should be treated at 2 weeks after giving birth and every 2 weeks until weaning. It is advisable to treat bitches and queens at the same time as the puppies or kittens.

### Older dogs and cats

200mg/kg as a single dose (1 tablet per 2.5kg body weight) at 9 months of age. Repeat treatment at 3 monthly intervals.

Do not repeat the treatment if vomiting occurs shortly after dosing.

Do not administer more than 6 tablets in a single dose. If no vomiting occurs the remaining dose may be given after 3 hours.

## **9. ADVICE ON CORRECT ADMINISTRATION**

Whilst Piperazine compounds have few side effects and are of low toxicity, care should be taken, especially with kittens and puppies to ensure that the correct dosage is calculated by accurately weighing the animal prior to administration of the drug. To weigh small pets, step on bathroom scales with and then without the animal. Animals weighing less than 1.25kg should be treated with a suitable anthelmintic for this purpose.
