A herbal medicine for the symptomatic relief of problems associated with whelping and kitting, and an aid in the prevention of pseudo pregnancy.

10. DOSAGE FOR EACH SPECIES, ROUTE(S) AND METHOD OF ADMINISTRATION

Recommended dosage:

To facilitate whelping or kitting:

1 tablet per 10kgs bodyweight daily from 3rd week of gestation until 1 week after whelping or kitting

To aid in the prevention of pseudo pregnancy:

2 tablets per 10kgs bodyweight daily from the start of the season for 12 weeks.


