This shampoo contains:

Pyrethrins equivalent to 0.475 mg/g as Pyrethrum Extract

Piperonyl Butoxide 4.9 mg/g

6. INDICATION(S)

Kills fleas. Helps to maintain a glossy healthy coat.

7. CONTRAINDICATIONS

Do not use on cats.

Do not use on puppies under 12 weeks of age.

Do not use on nursing bitches.

10. DOSAGE FOR EACH SPECIES, ROUTE(S) AND METHOD OF ADMINISTRATION

Follow the dosing chart:

Animal	Dosage	Number of application per bottle
Small dog (e.g. Terrier)	30ml	5
Medium size dog (e.g. Collie)	50ml	3
Large dog (e.g. Alsatian)	70 ml	2

11. ADVICE ON CORRECT ADMINISTRATION

Mix the recommended amount of shampoo with 300ml of lukewarm water. Wet the dog's coat thoroughly with warm water and apply half the mixture. Massage well in to the coat using fingertips around the head to avoid eyes, ears and mouth. Rinse and repeat with the remainder of the mixture working up to a good lather. Rinse well with lukewarm water and dry. Keep dog indoors until completely dry.

Bob Martin Clear Shampoo for dogs and puppies should be used as part of an effective flea control programme.

Fleas will often infest your pet's baskets, bedding and regular resting areas, including carpet and soft furnishings. These areas should be treated with a suitable household flea treatment and vacuumed regularly.

Do not store above 25°C.

Protect from frost and direct sunlight.

Keep away from food and drink and animal feeding stuffs.

i) Special precautions for use in animals

For external use only.
Avoid the animals eyes

ii) Special precautions to be taken by the person administering the veterinary medicinal product to animals

Wash hands and exposed skin after use. Avoid contact with eyes. In case of accidental eye contact, rinse with clean, fresh water. If eye irritation persists, seek medical advice.

Persons with known hypersensitivity (allergic reaction) to pyrethrum extract or other compounds in the product should not handle the product.

Treated animals should not be allowed to sleep or play with people, especially children, until the animal is dry.

Keep away from food and drink, including animal feeding stuffs

Remove fleas from young puppies and nursing bitches by careful use of a flea comb.
