6. INDICATION(S)

When used as a teat dip or teat spray Sensospray 70V is an aid in the prevention of mastitis in lactating dairy cattle, sheep and goats.

10. DOSAGE FOR EACH SPECIES, ROUTE(S) AND METHOD OF ADMINISTRATION

Before Milking: Wash teats with an udder wash solution and dry with a disposable paper towel.

After Milking: If signs of disease persist or appear, consult your veterinary surgeon.

Teat Dipping: Using Sensospray 70V fill dipping beakers two thirds full. Apply teat dip to each teat. Teat dipping beakers should be emptied after milking and washed before re-use.

Teat Spraying: If the spray nozzle is adjustable, use a coarse spray (not a fine mist) and spray the entire surface of each teat.

Do not store above 25 °C.
Protect from frost.
Protect from direct sunlight.

When used as a spray, avoid working in a spray mist.

Keep away from animal feed.
