Dogs and Cats

6. INDICATION(S)

For the relief of acute pain and inflammation associated with musculoskeletal and other painful disorders in the dog and cat. For the relief of pain in dogs associated with chronic osteoarthritic conditions.

7. METHOD AND ROUTE(S) OF ADMINISTRATION

By oral administration. For acute indications in dogs and cats, the recommended dosage is 1 tablet per 5 kg body weight (equivalent to 1.0 mg ketoprofen per kg) administered once daily for up to 5 days. Ketofen tablets may be given on the day following administration of Ketofen 1% Injection to maintain treatment for up to a total of 5 days. For chronic pain in dogs, the recommended dosage is 0.25 mg of ketoprofen per kg body weight administered once daily. The recommended duration of treatment is up to 30 days. If continued treatment is indicated beyond 30 days the animal should first be re-examined by the Veterinarian.

Administer Ketofen tablets immediately prior to food.
