**ABOUT THIS PRODUCT**

Bob Martin Clear Flea Collar for Cats will kill fleas and prevent further reinfestation for up to 4 months. Flea kill begins almost immediately, but it may take several days for the active ingredient to spread throughout the entire coat.

**7. METHOD AND ROUTE(S) OF ADMINISTRATION**

**DIRECTIONS FOR USE**

1. The collar will fit most cats. If fitted to a fully-grown cat, allow enough space for 2 fingers to be inserted between the collar and neck. If fitted to a growing cat, remember to loosen the collar as the cat gets bigger. Do not remove collar from pack until ready to use.

2. This collar has been specially designed to release your cat if it becomes caught up. To fit the collar, simply slide the free end through the buckle, and tighten to leave enough room to insert two fingers between the collar and neck. Remember to loosen the collar if fitted onto a growing cat. Cut off any excess collar with scissors and throw it away with your domestic rubbish. If your cat should become caught up, the special design will allow the collar to stretch, enabling your cat to slip its head out.

3. After four months use, remove the collar and dispose of it with any remaining product/packaging in the household refuse.

4. Fleas spend three-quarters of their life cycle off your pet, in bedding, carpets, and soft furnishings. Treat these areas with a suitable household insecticide, and vacuum regularly.

### PRECAUTIONS

Do not use this collar if your cat is under 6 months old, is nursing kittens, or has been treated with other insecticides. Also, you should not use other insecticide within 7 days of removal of the collar.

If your cat develops any sign of skin irritation, or signs of drowsiness, listlessness, or respiratory difficulties soon after fitting the collar, take it off immediately.

Fleas should be removed from young kittens and nursing females by careful use of a flea comb. If signs of disease persist or appear, consult your Veterinary Surgeon.

Do not allow animals to chew the collar.

Do not remove the collar from the pack until you are ready to fit it.

Do not allow children to play with the collar.

Do not allow children to suck or chew the collar.

Do not smoke, eat or drink while handling collar.

Do not sleep with pets wearing collars.

Avoid excessive handling of the collar.

If you feel unwell after handling the collar, seek medical advice.
