Beaphar Worming Cream is an oral suspension containing piperazine citrate (25% w/w)

For dogs, puppies, cats and kittens

6. INDICATION(S)

Eliminates roundworms in dogs, puppies, cats and kittens

7. METHOD AND ROUTE(S) OF ADMINISTRATION

Dosage & administration:

Beaphar Worming Cream is pleasantly flavoured, and no fasting or purging is necessary before administration. It may be administered either by dabbing the required amount (see table) onto the nose or mouth, from where the animal will lick it off, or given on a biscuit, or added to a small amount of the animal's daily meal (give the remainder afterwards to ensure that all of the Worming Cream has been taken). If your household has more than one cat/dog, feed them separately to ensure each receives the correct dose. Each graduation of the syringe will dispense the correct volume of Worming Cream for 1 kg bodyweight. The syringe will treat up to 45 kg bodyweight. The syringe is marked with guidelines for each 1 kg bodyweight dose. To administer the correct volume, depress the plunger past the required number of graduations according to the weight of the animal.

Animal weight:

Puppies & kittens:

Should be treated for roundworms at 2 weeks of age. They should be retreated at 4, 6, 8, 10 and 12 weeks, and thereafter at 2 to 3 monthly intervals.

Adult dogs & cats:

Should be treated at 3 monthly intervals. Nursing females should be wormed at the same time, and as frequently, as their puppies or kittens until weaning.

Contra-indications/Warnings:

If signs of overdose occur (such as vomiting, diarrhoea, depression, muscle weakness, or fits) consult your Veterinary Surgeon, and keep dog/cat warm. Symptoms reverse in 24 hours. Consult your Veterinary Surgeon before treating pregnant animals, or those with a history of epilepsy or severe renal dysfunction. If signs of disease persist or appear, consult a Veterinary Surgeon. Following accidental skin or eye contact, wash the affected area with plenty of water. If irritation persists seek medical advice. Following accidental ingestion, drink plenty of water and seek medical attention. Wash hands and exposed skin after use.
