6. INDICATION(S)

For the treatment of seborrhoeic dermatitis in dogs.

7. CONTRAINDICATIONS

Do not use in cases of known hypersensitivity to the active ingredient.

8. ADVERSE REACTIONS

If signs of disease persist or appear, consult your veterinary surgeon.

9. TARGET SPECIES

Dogs

10. DOSAGE FOR EACH SPECIES, ROUTE(S) AND METHOD OF ADMINISTRATION

Wash the coat thoroughly using a mild shampoo. Then rinse.

Shake the container before use. Mix 25 to 100 ml depending upon the size of the animal with ¼ to 1 cup of warm water (50 – 200 ml). Avoid the eyes and lather well into the coat and skin. Do not allow the animal to lick the suspension. Leave the suspension in contact for 5-10 minutes. Then rinse thoroughly and dry.

Treatment should be repeated at intervals of one week, if necessary.

12. WITHDRAWAL PERIOD

13. SPECIAL STORAGE PRECAUTIONS

Do not store above 25°C.

14. SPECIAL WARNING(S)

SPECIAL PRECAUTIONS FOR USE IN ANIMALS:

For external use only. Detergents may irritate. The eyes of the animals may be protected by liquid paraffin or a mild ophthalmic ointment. Do not exceed the recommended volume of shampoo.

In the absence of specific studies conducted during pregnancy and lactation, use during these times is not recommended.

USER WARNINGS:

Protective waterproof gloves should be worn when using this product.

Wash hands and exposed skin thoroughly after use.

Poisonous if taken internally.

Avoid contact with eyes. If eye contact occurs, rinse with clean, running water and seek medical advice if irritation persists.

Do not use in cases of known hypersensitivity to the active ingredient.


