PRODUCT INFORMATION

Based on Chlorhexidine formulation and Benzalkonium Chloride which work together to reduce the bacterial contamination that causes mastitis in dairy herds.

When used routinely as a teat dip or spray, it will prove a valuable aid in helping control Bovine mastitis.

Contains 10.80% w/v Glycerol and 1.2% Sorbitol to help prevent and heal cracked and chapped teats and to keep them soft and supple.

Ready to use and so is especially suitable for situations where measurements and mixing are likely to prove inconvenient.

10. DOSAGE FOR EACH SPECIES, ROUTE(S) AND METHOD OF ADMINISTRATION

Teat Dipping

Fill teat cup about two thirds full with the product.

Dip teats of every cow immediately after each has been milked, making sure that the full length of the teat is immersed. Top up with fresh solution as required.

Teat dip cups should be emptied and washed after use. **Teat Spraying**

Immediately after milking, spray the entire surface of each teat of every cow with the product.

Udder Washing and Cluster Dipping

Dilute in the proportion of 150ml to 10 litres of clean water. To help prevent cross infection, individual cloths or disposable paper towels are strongly recommended. Immerse clusters and agitate for at least half a minute. Rinse in clean water before use. Wash and dry udders and teats before milking.

11. ADVICE ON CORRECT ADMINISTRATION

When using as a spray, avoid working in spray mist

Avoid contact with eyes. In case of contact with eyes, give prolonged irrigation with water and seek medical advice

In case of ingestion seek medical advice immediately.

Do not eat, drink or smoke whilst using this product

Keep away from food, drink and animal feeding stuffs.

Wash hands after use.

12. WITHDRAWAL PERIOD

Meat – zero days Milk – zero hours.

13. SPECIAL STORAGE PRECAUTIONS

Store in tightly closed original container

Do not store above 25°C.

Protect from frost.

If contents freeze they must be thawed and thoroughly mixed before use.
