**1. NAME OF THE VETERINARY MEDICINAL PRODUCT**

Wormazole 440 mg Granules for dogs

**2. STATEMENT OF ACTIVE AND OTHER SUBSTANCES**

2 grams Wormazole contains 440 mg fenbendazole.

**3. PHARMACEUTICAL FORM**

Granules

Wormer for dogs

**4. PACKAGE SIZE**

2 gram

**5. TARGET SPECIES**

Dogs

**6. INDICATION(S)**

For the treatment of adult dogs infected with roundworms and tapeworms (*Toxocara canis*, *Toxascaris leonina*, *Ancylostoma* spp, *Trichuris* spp *Uncinaria* spp and *Taenia* spp). Also effective against lungworms *Oslerus (Filaroides) osleri* and protozoa *Giardia* spp.

For the treatment of weaned puppies infected with roundworms and puppies infected with protozoa *Giardia* spp. For the treatment of pregnant bitches to reduce prenatal infections with *Toxocara canis* and the transfer of *T. canis* and *Ancylostoma caninum* to their pups via the milk.

## **7. METHOD AND ROUTE(S) OF ADMINISTRATION**

### **Mixes into feed**

#### **This 2 gram sachet treats:**

**Routine treatment of adult dogs** - 1 sachet Wormazole per 4.4 kg (10 lbs) bodyweight on a single occasion.

**Weaned puppies** - under 6 months of age, protozoa Giardia infections - 1 sachet per 8.8 kg (20 lbs) bodyweight daily for 3 days.

**Pregnant bitches** - 1 sachet per 17.6 kg (40 lbs) daily from day 40 of pregnancy to 2 days post whelping (approximately 25 days).

**Lungworm in dogs** - 1 sachet per 8.8 kg (20 lbs) bodyweight daily for 7 days. A repeat treatment may be necessary.

Wormazole granules are odourless and tasteless and are readily consumed by animals.

Treatment should be repeated when natural reinfestation of animals with parasitic worms occurs.

Treatment of adult dogs is advisable 2 to 4 times a year.

Puppies should be treated at 2 weeks of age and again at 5 weeks of age. Further treatments are recommended at 8 and 12 weeks of age.

Thereafter frequency of treatment can be reduced unless the pups are housed in a kennel environment where reinfection occurs more readily.

Assess bodyweight as accurately as possible before calculating the dosage.

**1. NAME OF THE VETERINARY MEDICINAL PRODUCT**

Wormazole 440 mg Granules for dogs

**2. STATEMENT OF ACTIVE AND OTHER SUBSTANCES**

A granulate formulation of fenbendazole as a ready to use oral anthelmintic.

2 gram Wormazole contains 440 mg fenbendazole.

**3. PHARMACEUTICAL FORM**

Granules

Wormer for dogs

**4. PACKAGE SIZE**

2g x 100 sachets

**5. TARGET SPECIES**

Dogs

**6. INDICATION(S)**

For the treatment of adult dogs infected with roundworms and tapeworms (*Toxocara canis*, *Toxascaris leonina*, *Ancylostoma* spp, *Trichuris* spp *Uncinaria* spp and *Taenia* spp). Also effective against lungworms *Oslerus (Filaroides) osleri* and protozoa *Giardia* spp.

For the treatment of weaned puppies infected with roundworms and puppies infected with protozoa *Giardia* spp. For the treatment of pregnant bitches to reduce prenatal infections with *Toxocara canis* and the transfer of *T. canis* and *Ancylostoma caninum* to their pups via the milk.

## 7. METHOD AND ROUTE(S) OF ADMINISTRATION

Part used sachets should not be administered.

### Recommended doses:

Routine treatment of adult dogs: 1 g Wormazole per 2.2 kg (5 lbs) bodyweight as a single dose (= 100mg fenbendazole per kg bodyweight)

Weight of animal	Dose required
2.2 to 4.4 kg (5-10 lbs)	2 grams
4.5 to 8.8 kg (10-20 lbs)	4 grams
8.9 to 13.2 kg (20-30 lbs)	6 grams
13.3 to 22 kg (30-50 lbs)	10 grams
22.1 to 35.2 kg (50-80 lbs)	16 grams
35.3 to 50 kg (80-110 lbs)	22 grams

Treatment should be repeated 2 to 4 times per year as natural re-infection with worms occurs. More frequent treatment at 6 to 8 weekly intervals is advisable for dogs in kennels.

### Increased dosing for specific infections:

For the control of lungworm *Oslerus (Filaroides) osleri* in dogs - 1 gram Wormazole per 4.4 kg (10 lbs) bodyweight daily for 7 consecutive days. A repeat course of treatment may sometimes be required.

Weaned puppies under six months of age - 1 gram Wormazole per 4.4 kg (10 lbs) bodyweight daily for 3 consecutive days.

Puppies should be treated at 2 weeks of age, 5 weeks of age and again before leaving the breeder's premises.

Further treatments are recommended at 8 and 12 weeks of age. Thereafter, frequency can be reduced unless the pups are housed in kennels where reinfection occurs more readily.

Recommended doses:

Weaned puppies under 6 months of age: 1 g Wormazole per 4.4kg (10 lbs) bodyweight daily for three consecutive days (= 50mg fenbendazole per kg bodyweight for 3 days)

2.2 - 4.4 kg (5-10 lbs)	1 gram per day	3 grams

8.9 - 13.2 kg (20-29 lbs)	3 grams per day	9 grams
13.3 - 17.6 kg (30-40 lbs)	4 grams per day	12 grams

Pregnant bitches:

1 gram Wormazole per 8.8 kg (20 lbs) bodyweight daily from day 40 of pregnancy to 2 days post-whelping (approximately 25 days) (= 25mg fenbendazole per kg bodyweight daily).
