Remove the hair around the embryo horn by cutting. Smear petroleum jelly around the bud then apply a small, pea-sized amount of paste to cover entire horn bud, using the attached spatula. Replace cap tightly after use.

12. WITHDRAWAL PERIOD

Meat – zero days

13. SPECIAL STORAGE PRECAUTIONS

Do not store above 25°C. Do not freeze. Protect from direct sunlight.

Allow 1 ½ hours of dry weather when applying paste. Keep cow away from calf for half an hour following application. Keep paste away from calf's eye.
