# 3. STATEMENT OF THE ACTIVE SUBSTANCE(S) AND OTHER INGREDIENTS

Contains 2.15% w/v available iodine and 2% w/v glycerol and 18% w/v sorbitol.

# 4. PHARMACEUTICAL FORM

LEYODIP 2.15% w/v concentrate teat dip and teat spray solution is a controlled iodine concentrate teat dip in the form of a dark brown liquid.

# 5. PACKAGE SIZE

5,25,60,200

Additional wording required on 200 litre label:

200 litre label: This container should only be used once and should not be returned for re-filling.

# 6. INDICATION(S)

LEYODIP 2.15% w/v concentrate teat dip and teat spray solution should be used routinely, at the recommended dilute rates, as a teat dip, teat spray, udder washand milking machine cluster dip, as part of a programme to control bovine mastitis and as an aid in the prevention and healing of cracked and chapped teats.

Dairy cows.

# 4. DOSAGE FOR EACH SPECIES, ROUTE(S) AND METHOD OF ADMINISTRATION

#### TEAT DIPPING:

Prepare a fresh solution of 1 part LEYODIP 2.15% w/v CONCENTRATE TEAT DIP and TEAT SPRAY SOLUTION with three parts water, to give 5000ppm minimum available iodine. Fill teat dipping cup about two-thirds full with this prepared solution and dip each teat immediately after each cow is milked. Top up the cup with fresh solution if necessary. Teat dip cups should be emptied and washed after milking.

#### TEAT SPRAYING:

Prepare a fresh solution of 1 part LEYODIP 2.15% w/v CONCENTRATE TEAT DIP and TEAT SPRAY SOLUTION with three parts water. Immediately after milking spray entire surface of each teat of every cow with the solution.

UDDER WASHING and CLUSTER DIPPING:

Use in the proportion of 1 part LEYODIP 2.15% w/v CONCENTRATE TEAT DIP and TEAT SPRAY SOLUTION to 500 parts water, i.e. 20 ml in 10 litres or 1 fl oz in 3 gallons, to give 40ppm available iodine.

Udder cloths should be allowed to soak in the solution. The use of separate udder cloths for each cow, or disposable paper towels is strongly recommended. Teat clusters should be immersed and agitated for at least 30 seconds before milking each cow.

# CONCENTRATE

The following safety phrases relate to the concentrated product only, and do not apply once the product is diluted to the working solution:

Risk of serious damage to eyes. Wear eye/face protection when preparing the dip or spray.

#### DILUTED WORKING SOLUTION

When using as a spray, avoid working in spray mist.

Avoid contact with eyes.

In case of contact with eyes, rinse immediately with plenty of water and seek medical advice.

If swallowed, seek medical advice immediately and show this container or label.

Hands and exposed skin should be washed after using this product.

Do not eat, drink or smoke while using the product.

Keep away from food, drink and animal feedstuffs.
