Wash and dry teats and udder before next milking.

### **Teat spraying**

This product is ready to use and should not be diluted. Immediately after each milking, spray the entire surface of each teat using a suitable sprayer.

Wash and dry teats and udder before next milking

For external use only.

When using as a spray, avoid working in spray mist.

Avoid contact with eyes.
