2. NAME OF THE VETERINARY MEDICINAL PRODUCT

Nobilis CAV P4

Lyophilisate and solvent for suspension for injection

3. STATEMENT OF THE ACTIVE SUBSTANCE (S) AND OTHER INGREDIENTS

Vaccine: $\geq 3.0 \log_{10}$ TCID₅₀ live attenuated CAA virus strain 26P4 per dose of 0.2 ml
Solvent (Dilavia) contains dl- α -tocopherol acetate.

4. INDICATION(S)

For active immunisation of broiler breeders to stimulate the production of antibodies to chicken anaemia virus – to reduce mortality and clinical signs due to chicken anaemia virus in progeny produced during the laying period after vaccination. Immunity has been demonstrated 6 weeks after vaccination. Antibody at a level which has been shown to prevent excretion of challenge virus has been demonstrated for at least 10 weeks after vaccination under controlled laboratory conditions. There is some limited evidence from use in the field that the duration of immunity may be longer, possibly up to 42 weeks.

5. CONTRAINDICATIONS

Do not vaccinate birds below 6 weeks of age under any circumstances.
Do not vaccinate birds in the last six weeks before lay or birds in lay.

Do not use in multi-age sites.

6. ADVERSE REACTIONS

No clinical signs have been associated with an overdose of the vaccine. If you notice any serious effects or other effects not mentioned in this leaflet, please inform your veterinary surgeon.

7. TARGET SPECIES

Chickens (broiler breeders).

8. DOSAGE FOR EACH SPECIES, ROUTE(S) AND METHOD OF ADMINISTRATION

Reconstitute the vaccine using the diluent provided, allowing 0.2 ml diluent per dose i.e. 200 ml per 1000 doses. Administer 0.2 ml to every bird by intramuscular or subcutaneous injection. Equipment used for vaccination should be sterile and contain no traces of detergents or disinfectants.

Vaccination programme

The optimum age and route (IM or SC) of vaccination depend on the local situation and should be determined by the site veterinarian. The chicks must be at least 6 weeks of age before vaccination, and must be vaccinated at least 6 weeks before the expected onset of lay.

9. ADVICE ON CORRECT ADMINISTRATION

None.

10. WITHDRAWAL PERIOD(S)

Zero days.

11. SPECIAL STORAGE PRECAUTIONS

Vaccine: Store at 2 °C - 8 °C. Do not freeze. Protect from light. Solvent: Do not store above + 25 °C. Do not freeze. Protect from light. Keep out of the sight and reach of children. Shelf life after reconstitution: 2 hours Do not use after the shorter expiry date stated on the vaccine or solvent label.

12. SPECIAL WARNING(S)

Do not use in unhealthy birds. Sick or weak birds will not develop adequate immunity following vaccination. The CAA vaccine virus has the ability to spread from vaccinates to susceptible birds. Care should be taken to avoid spread to very young birds and birds in lay. A good immune response is reliant on the reaction of an immunogenic agent and a fully competent immune system. Immunogenicity of the vaccine antigen will be reduced by poor storage or inappropriate administration.

Immuno-competence of the animal may be compromised by a variety of factors including poor health, nutritional status, genetic factors, concurrent drug therapy and stress.

Use during lay

The vaccine must not be used in the last 6 weeks before lay or during lay.

Special precautions to be taken by the person administering the veterinary medicinal product to animals

Wash and disinfect hands and equipment after vaccination

Interactions

No information is available on the compatibility of this vaccine with any other. Therefore the safety and efficacy of this product when used with any other (either when used on the same day or at different times) has not been demonstrated.

Incompatibilities

Do not mix with any other veterinary medicinal product apart from the diluent provided.

13. SPECIAL PRECAUTIONS FOR THE DISPOSAL OF UNUSED PRODUCT OR WASTE MATERIALS, IF ANY

Dispose of waste material by boiling, incineration or immersion in an appropriate disinfectant approved for use by the competent authorities.

Carton with 1 or 10 glass vials of hydrolytical type I glass (Ph.Eur.) containing the freeze-dried pellet containing 500 or 1000 doses. The vial is closed with a halogenobutyl rubber bung (Ph. Eur.) and sealed with a coded aluminium cap.

Solvent(Dilavia)

Carton with 10 vials of hydrolytical type II glass (Ph. Eur.) or PET containing 100 or 200 ml solvent, closed with halogenobutyl rubber bung (Ph. Eur.) and sealed with a coded aluminium cap.
