Take care to ensure that the product is applied directly to the skin and not squeezed on to the hair, as this will cause a sticky appearance of hairs at the treatment spot. Should this occur however, it will disappear within 24 hours after you have applied the product.

Do not treat your dog more frequently than every 4 weeks.

- **Do not use in rabbits, as adverse reactions and even death could occur.**
- Do not use in animals with known hypersensitivity (allergy) to the active substance or to any of the other ingredients.

FRONTLINE Spot On Dog prevents re-infestation of ticks (*Rhipicephalus spp*, *Dermacentor spp* and *Ixodes spp*) for up to one month depending on the number of ticks in your dog’s environment. The product does not prevent all ticks from attaching to the animal, but ticks will be killed in the first 24-48 hours after attachment, minimising the risk of transmission of disease. Single ticks may still become attached to your dog however, and therefore transmission of infectious diseases cannot be ruled out.
