3. STATEMENT OF THE ACTIVE SUBSTANCE (S) AND OTHER INGREDIENTS

4. INDICATION(S)

For use as an aid, together with managemental and hygienic measures, in the control of enzootic pneumonia in fattening pigs caused by Mycoplasma hyopneumoniae.

5. CONTRAINDICATIONS

The use of immunosuppressant drugs or procedures is contraindicated within one month of vaccination.

6. ADVERSE REACTIONS

A small proportion of animals may be unable to develop or maintain an adequate immunity following vaccination. Very occasionally, administration of the vaccine may be followed by a mild, transient reaction at the injection site. These reactions are

limited to swelling with or without redness, and mild tenderness to direct pressure. The reactions have not been observed to cause alterations of normal behaviour in affected pigs. The reactions resolve spontaneously within a few days, do not cause blemishes of the carcase at slaughter, and no remedial action need be taken.

If an anaphylactic reaction occurs, administer adrenaline or other appropriate medication.

8. DOSAGE FOR EACH SPECIES, ROUTE(S) AND METHOD OF ADMINISTRATION

2 ml administered by the deep intramuscular route, preferably behind the ear and through an area of clean dry skin, taking precautions to avoid contamination. Shake well before use. Two doses should be given to piglets. The 1st dose at one week of age and the 2nd dose 2-4 weeks later. Older pigs (3-6 weeks old) may be vaccinated against enzootic pneumonia, especially if they are to be moved from premises where the incidence of the disease is low to premises where the disease incidence is higher. In this case each pig should be vaccinated twice, with an interval between doses of 2-4 weeks, before shipping. However, it should be remembered that pigs vaccinated for the first time at more than one week of age may already have pulmonary changes due to Mycoplasma infection and that therefore, the protection conferred by vaccination may not be as strong as that seen when younger piglets are vaccinated.

9. ADVICE ON CORRECT ADMINISTRATION

Shake well before use. Ensure vaccination equipment is clean and sterile before use and remains so during vaccination. Small quantities of unused product and empty vials are to be disposed of safely by burning, or by immersion in an approved disinfectant before disposal.
