6. INDICATION(S)

When used as a teat dip or teat spray LuxSpray 50V is an aid in the prevention of mastitis in lactating dairy cows, sheep and goats.

Before Milking: Wash teats with an udder wash solution and dry with a disposable paper towel.

After Milking: If signs of disease persist or appear, consult your veterinary surgeon.

Teat Dipping: Using LuxSpray 50V fill dipping beakers two thirds full. Apply teat dip to each teat. Teat dipping beakers should be emptied after milking and washed before re-use.

Teat Spraying: If the spray nozzle is adjustable, use a coarse spray (not a fine mist) and spray the entire surface of each teat.
