6. INDICATION(S)

As an aid in the reduction of inflammation and to alleviate pain in horses.

10. DOSAGE FOR EACH SPECIES, ROUTE(S) AND METHOD OF ADMINISTRATION

Hot

Take the required amount of poultice from the tub and put into a container suitable for heating. Place the container in hot water making sure that no water can get into the poultice. Stir thoroughly, making sure that the poultice is heated evenly, then spread thickly onto lint or any other suitable material. Apply to the affected area and bandage lightly. The poultice may be left on for 12 – 24 hours (according to veterinary advice) and then wash off to remove.

Natural

Kaolin Poultice may also be used straight from the tub. No heating or cooling is required. Take the required amount of poultice from the tub and spread thickly onto lint or any other suitable material and bandage to the affected area. Wash off to remove.

Cold

Take the required amount of poultice from the tub and spread thickly onto lint or any other suitable material. Place in a fridge to chill to the required temperature. Bandage to the affected area. Wash off to remove.

11. ADVICE ON CORRECT ADMINISTRATION

Use as directed, or as instructed by a veterinarian

Test the temperature of the poultice before applying to the affected area. If signs of disease persist or appear, consult a veterinary surgeon.

Ensure that the bandage is not applied too tightly so as not to constrict circulation.

12. WITHDRAWAL PERIOD

Not to be used in horses intended for human consumption. Treated horses may never be slaughtered for human consumption. The horse must have been declared as not intended for human consumption under national horse passport legislation.

13. SPECIAL STORAGE PRECAUTIONS

Do not store above 30 °C

Store in the original container. Keep the container tightly closed

14. SPECIAL WARNING(S)

This product may cause skin and eye irritation. Avoid contact with skin and eyes.

Wear impervious gloves when using the product.

In the event of contact with the eyes, rinse immediately with plenty of clean water for several minutes. Seek medical attention if irritation persists.

In the event of contact with the skin, rinse immediately with plenty of clean water. Seek medical attention if irritation persists.

Wash hands and exposed skin thoroughly after use.
