## 11. ADVICE ON CORRECT ADMINISTRATION

Gently wet your dog’s coat with lukewarm water. Using the suggested dose below, massage the shampoo into the coat, taking care to avoid sensitive areas, such as the eyes, mouth and ears. Work into a good lather, especially around the neck area and the base of the tail where fleas tend to gather. Rinse carefully with lukewarm water and then dry your pet. Keep indoors until completely dry.

Do not store above 25°C.  
Protect from light.  
Do not refrigerate.  
Protect from direct sunlight.  
Protect from frost.

For external use only.

Wash any containers used thoroughly.

Fleas often infest a pet's bedding and its immediate environment, such as carpets and soft furnishings. Treat these areas with a suitable insecticide and vacuum areas regularly.

Avoid prolonged contact with skin. It is advisable to wear gloves whilst using this product. Avoid contact with eyes. In case of accidental eye contact, rinse well with clean fresh water. If eye irritation persists, seek medical advice. Treated animals should not be allowed to sleep or play with people, particularly children, until animal is dry. Keep away from food and drink including animal feeding stuffs. Wash hands and exposed skin after use. Replace cap.
