**1. NAME OF THE VETERINARY MEDICINAL PRODUCT**

Calciject 40 CM Solution of Injection

**2. STATEMENT OF ACTIVE AND OTHER SUBSTANCES**

Each ml contains:

400mg Calcium Borogluconate and 50mg Magnesium Hypophosphite Hexahydrate.

Each 400 ml contains: 11.9g calcium (provided by calcium gluconate and calcium borogluconate) and 1.85g magnesium (provided by magnesium hypophosphite) and 6.84% w/v boric acid.

Solution for Injection

**5. TARGET SPECIES**

Cattle

**6. INDICATION(S)**

Calciject 40 CM is indicated in the treatment of hypocalcaemia in cattle where increased blood magnesium levels are also required.

**7. METHOD AND ROUTE(S) OF ADMINISTRATION**

By subcutaneous or slow intravenous injection.

Cattle: 200 - 400 ml.

**8. WITHDRAWAL PERIOD**

Withdrawal period for meat/milk - Zero Days/Hours

**9. SPECIAL WARNING(S), IF NECESSARY**

Normal aseptic precautions should be observed. The solution should be warmed to body temperature before administration. Intravenous injections should be given slowly, in order to avoid possible neuromuscular dysfunction and cardiac insufficiency. Sites of subcutaneous administration should be massaged gently. This product does not contain an antimicrobial preservative. Any solution remaining in the vial following withdrawal of the required dose should be discarded. Care should be taken to avoid accidental self-injection: may cause irritation at site of injection.
