1. NAME OF THE VETERINARY MEDICINAL PRODUCT

Fenbendazole

2. STATEMENT OF ACTIVE SUBSTANCES

Each 4g sachet of granules contains 889 mg fenbendazole.
White to off-white, free flowing, coarse granules.

6. INDICATION(S)

Bob Martin Clear Wormer Granules for Dogs 888.8 mg is a highly effective one dose treatment for roundworm and roundworm eggs. Clinically proven, simply sprinkle the granules into your dog's food to help keep them roundworm free.

7. METHOD AND ROUTE(S) OF ADMINISTRATION

Weigh your pet carefully before calculating the dose. Sprinkle the required number of sachets onto about a 1/3 of your dog's food and mix well. Once this food has been consumed the remainder of the dog's food can be given. If you have more than one dog treat each dog separately and ensure that other dogs do not have access to the treated food.

Dosage:

For routine control of roundworms and roundworm eggs in dogs over 6 months, and weighing 8.8 kg (19lb 6oz) or more, give 1 x 4 g sachet per 8.8 kg (19lb 6oz) bodyweight as a single dose.

For dogs weighing over 35.2 kg (77lb 10oz) additional packs will be required.
Give an additional 1 x 4 g sachet for every additional 8.8 kg (19lb 6oz) bodyweight.
Discard any remaining medicated feed.

Roundworm re-infection can occur at any time so veterinarians recommend that adult dogs be wormed every 3 months as a preventative measure.

9. SPECIAL WARNING(S), IF NECESSARY

Avoid allowing the granules to come into contact with your skin. As a precaution always wash your hands after use. Avoid inhaling granule dust.

Do not administer to pregnant bitches. Do not administer if your dog is sick or recovering from an illness. If sign of disease persist or appear, consult your veterinary surgeon.

Store in a dry place.
Keep the sachets in the outer carton.
Do not use this veterinary product after the expiry date which is stated on the carton after EXP. The expiry date refers to the last day of that month.

Dispose of empty packaging and any remaining product in the household refuse.


