Contains 0.425% w/w chlorhexidine gluconate (as chlorhexidine gluconate solution 2.250%) and glycerol 3.0% w/w

Teat dip and teat spray solution.

Ready to use chlorhexidine teat dip ad teat spray for use as an aid in the control of bovine mastitis

9. TARGET SPECIES

Dairy cows

10. DOSAGE FOR EACH SPECIES, ROUTE(S) AND METHOD OF ADMINISTRATION

Wash and dry udders and teats before milking.

Teat dipping:

Directly after milking each cow, dip the full length of each teat in the ready to use solution. No dilution is required. The teat cup should be filled to about 2/3 full. Replenish the teat dip cup as necessary. Empty after milking and wash before re-use.

Teat spraying:

Immediately after milking each cow, spray the entire surface of each teat of every cow with the ready to use solution. No dilution is required.

If signs of disease persist or appear, consult your veterinary surgeon.

11. ADVICE ON CORRECT ADMINISTRATION

Do not mix with other chemicals

12. WITHDRAWAL PERIOD

Meat/Milk: Zero days/hours

13. SPECIAL STORAGE PRECAUTIONS

Do not store above 25°C.

Protect from frost

Protect from direct sunlight. Store away from direct sunlight

Store in manufacturer's original container with top on.

Keep away from animal feed.

14. SPECIAL WARNING(S)

For external use only

Avoid contact with eyes. If splashed in the eye, rinse with clean running water immediately. When used as a spray, avoid working in spray mist. In case of ingestion seek medical attention immediately. Do not eat, drink or smoke whilst using the product. Keep away from animal feed. Wash hands after use.
