## **10. DOSAGE FOR EACH SPECIES, ROUTE(S) AND METHOD OF ADMINISTRATION**

### **Pre milking**

Wash udders and teats and dry with disposable paper towel before next milking.

### **Post milking**

#### **Teat dipping**

Fill the dipping beakers 2/3 full and apply to the teats of lactating cows, sheep or goats immediately after milking.

#### **Teat spraying**

Immediately after the milking of cows, sheep and goats spray the entire surface of each teat. If the spray nozzle is adjustable, use a coarse spray (not a fine mist).

## **11. ADVICE ON CORRECT ADMINISTRATION**

- When using as a spray, avoid working in spray mist.
- Avoid contact with eyes. In case of contact with eyes, rinse immediately with plenty of water and seek medical advice.
- If swallowed, seek medical advice immediately and show this container or label.
- Hands and exposed skin should be washed after using this product.
- Do not eat, drink or smoke while using this product.
- Keep away from food, drink and animal feedstuffs.
