1. NAME OF THE VETERINARY MEDICINAL PRODUCT

Johnson's 4Fleas shampoo for dogs 1.05% w/v

2. STATEMENT OF ACTIVE AND OTHER SUBSTANCES

Contains Permethrin (25:75) 1.05% w/v

6. INDICATION(S)

For the control of fleas on dogs over 12 weeks of age.

7. METHOD AND ROUTE(S) OF ADMINISTRATION

Directions for use: For the control of fleas on dogs over 12 weeks of age. Wet the dog's coat with tepid water and then work in the shampoo to form a good lather, using about 30ml for a medium size dog. Alternatively, add 30ml shampoo to 600ml water (1 fl oz to 1 pint) and work the mixture into the dry coat of the dog. Additional water may be added as required during lathering. Leave for two minutes while the dog is held, rinse off with tepid water and allow to dry naturally. If necessary, repeat after seven days or until infestation is cleared.

8. WITHDRAWAL PERIOD

Not applicable.

9. SPECIAL WARNING(S), IF NECESSARY

Contra-Indications, Warnings, etc: Do not use on cats. Do not use on nursing bitches or on puppies under 12 weeks of age. If signs of disease persist or appear, consult a veterinary surgeon.

Operator Warnings: Wash hands and exposed skin after use. Avoid prolonged contact with skin. It is advisable to wear gloves whilst using this product. Avoid contact with eyes. In case of accidental eye contact, rinse with clean, fresh water. If eye irritation persists, seek medical advice. Treated animals should not be allowed to sleep or play with people, particularly children, until the animal is dry. Keep away from food and drink, including animal feeding stuffs. Harmful to fish and crustaceans – do not contaminate aquaria or fish bowls with the product. For external use only. Keep out of reach of children.

Further Information:

Remove fleas from young puppies and from nursing bitches by careful use of a flea comb. Fleas from pets often infest animals' baskets, bedding and regular resting areas such as carpets and soft furnishings, which should be treated with a suitable insecticide and vacuumed regularly.


