4. INDICATIONS

For active immunisation of broiler chicks to reduce intestinal colonisation, intestinal lesions and clinical signs of Coccidiosis caused by *Eimeria acervulina*, *Eimeria maxima*, *Eimeria mitis*, *Eimeria praecox* and *Eimeria tenella*.

The onset of immunity is 14 days post-vaccination and the duration of protection is maintained at least for 42 days post-vaccination.

8. DOSAGE FOR EACH SPECIES, ROUTE(S) AND METHOD OF ADMINISTRATION

Oral in the drinking water or coarse spray.

Via Drinking water:

Chicken: 0.007 ml vaccine/bird, of 1 day of age.

Only hand-filled supplementary drinkers must be used.

Shake the suspension vigorously 5 to 10 times before use.

Dilute the vaccine in clean, room temperature water (avoid the use of very cold or very hot water) at a rate of 1,000 doses in up to ten litres.

Stir gently until the vaccine is fully homogenized.

Fill each drinker with 1 to 1.5 litres depending on the animals per drinker.

Administer a single dose of HIPRACOX BROILERS (0.007 ml) to each chick of 1 day of age.

Via Coarse spray:

Chicken: 0.007 ml vaccine/bird + 0.02 ml UNIFLOCK/bird, of 1 day of age.

A suitable clean container of enough capacity (287 ml for 1000 doses or 1435 ml for 5000 doses) is required.

Add clean water at room temperature (260 ml for 1000 doses or 1300 ml for 5000 doses).

Shake the vial of UNIFLOCK. Add it into the water and stir gently until it is fully homogenized.

Shake the vial of HIPRACOX BROILERS. Add it into the mixture and stir gently until it is fully homogenized. Fill the spraying device with all the mixture and maintain it in continuous homogenisation.

Spray 28 ml of the mixture to 100 chicks. The pressure of the spraying device should be at 3 bars. The spraying device must provide a droplet size of \geq 100 μ m.

9. ADVICE ON CORRECT ADMINISTRATION

Chickens must be strictly floor-reared on litter.

Litter should be removed and facilities and material cleaned between production cycles to reduce field infections.

Via Drinking water:

Water should be withheld for 2-4 hours prior to vaccination.

For the drinking water administration, the vaccine must only be administered with hand-filled supplementary drinkers. Do not use any other type of water distribution system for vaccination such as bell drinkers, nipple drinkers and automatic cup drinkers.

Generally for drinking water administration, 10 litres of water per 1,000 one-day-old broiler chicks are needed. Ensure that you have mini drinkers at a rate of 1 drinker every 100-150 birds. Make sure that drinkers are clean and not placed under the brooders.

Provide adequate number of drinkers and distribute them homogeneously so that all chicks have access to the vaccinal water.

It is important to ensure that too many birds do not gather around one drinker.

Routine administration of water may continue when the treated water has been fully consumed.

Via Coarse spray:

After vaccination, maintain the chicks inside the chick boxes for at least 1 hour. After this time, place the chicks in the litter and continue with regular management practices.

Use only the colouring agent UNIFLOCK.

No anticoccidial drugs or other agents having anticoccidial activity via feed or water should be used for at least 3 weeks following vaccination of the chickens. The correct replication of the vaccine oocysts and consequently, the development of a solid immunity could be hindered. Additionally, the enhancement of protection produced by oocyst re-infections would also be limited.

The vaccine will not protect species other than chickens against Coccidiosis and is only effective against the Eimeria species indicated.
