1. NAME OF THE VETERINARY MEDICINAL PRODUCT

Garlic and Fenugreek Sugar Coated Tablets

2. QUALITATIVE AND QUANTITATIVE COMPOSITION

Active Substances: Each tablet contains;
Fenugreek (powdered) 16.0mg
Essential Oil of Garlic 0.22mg

Excipients:

Titanium Dioxide (E171) 4.67mg

Coated tablet

White sugar coated tablet, 7.93mm diameter

4. CLINICAL PARTICULARS

4.1 Target species

Dogs and cats

4.2 Indications for use

A herbal medicine for the symptomatic relief of rheumatism, arthritis, skin conditions, coughs and minor infections in dogs and cats.

4.3 Contra-indications

None

4.4 Special warnings for each target species

Dogs – None necessary

Cats – None necessary

4.5 Special precautions for use

- i) Special precautions for use in animals

If condition fails to improve within 7 days, consult a veterinary surgeon

- ii) Special precautions to be taken by the person administering the medicinal product to animals

Wash hands after use

4.6 Adverse reactions (frequency and seriousness)

Based on post marketing experience and complementary data on very rare occasion diarrhoea and emesis have been reported.

The frequency of adverse reactions is defined using the following convention:

- very common (more than 1 in 10 animals treated displaying adverse reaction(s))
- common (more than 1 but less than 10 animals in 100 animals treated)
- uncommon (more than 1 but less than 10 animals in 1,000 animals treated)
- rare (more than 1 but less than 10 animals in 10,000 animals treated)
- very rare (less than 1 animal in 10,000 animals treated, including isolated reports).

1 tablet per 5-10kgs bodyweight daily as a maintenance dose.


